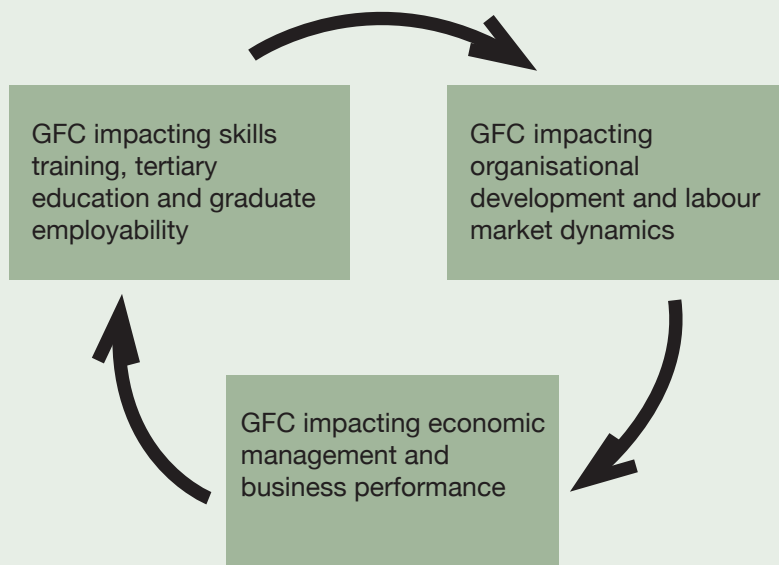
With increasing commercial forces and a globally competitive marketplace there is constant pressure to compress the lag between demand for and supply of appropriately educated and trained staff.
